How do I open and manage my account?	<p>Available to UK Residents and UK Tax Residents. One account per member.</p> <p>Complete the application form, relevant declaration(s) and provide necessary identification then forward together with the initial deposit (payable to the account holder) to the Society's office.</p> <p>Your initial deposit must be between £10 and £1,000. No other deposits are possible other than one deposit per calendar month of any amount between £10 and £1,000.</p> <p>The account can be managed via post and branch.</p> <p>Please contact the Society for information regarding Third Party Assistance.</p>	
Can I withdraw money?	<p>Yes, one notice and penalty free withdrawal per calendar year (1st January to 31st December) is permitted. All other withdrawals are subject to a penalty of 30 days loss of interest on the amount withdrawn.</p> <p>You can normally make a withdrawal on demand of cash up to £500 and any amount by cheque or Faster Payment, subject to adequate cleared balance and written instruction signed by the relevant signatory(ies).</p> <p>Refer to our General Savings Terms and Conditions and the Framework Contract for Payment Services for more information on withdrawals.</p>
